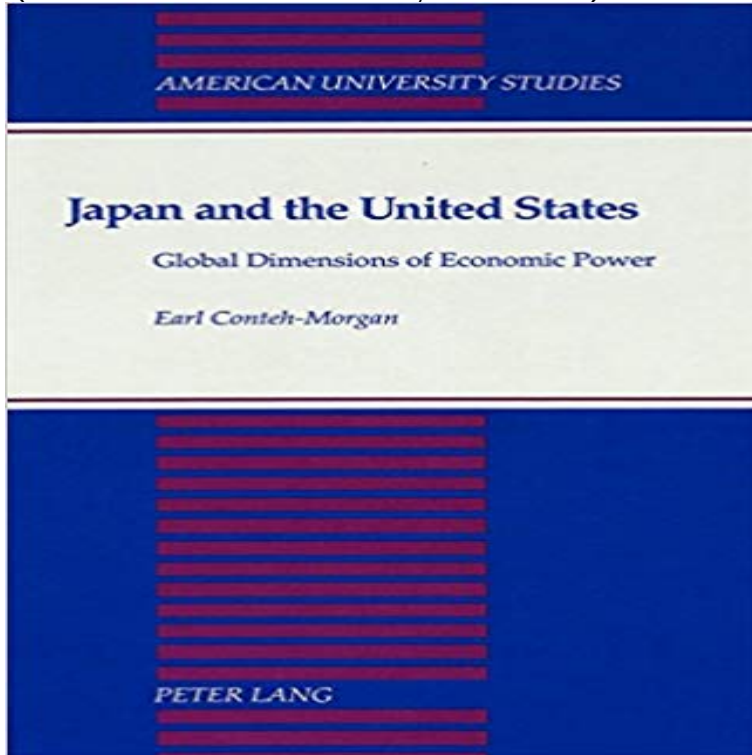


Japan and the United States: Global Dimensions of Economic Power (American University Studies)
