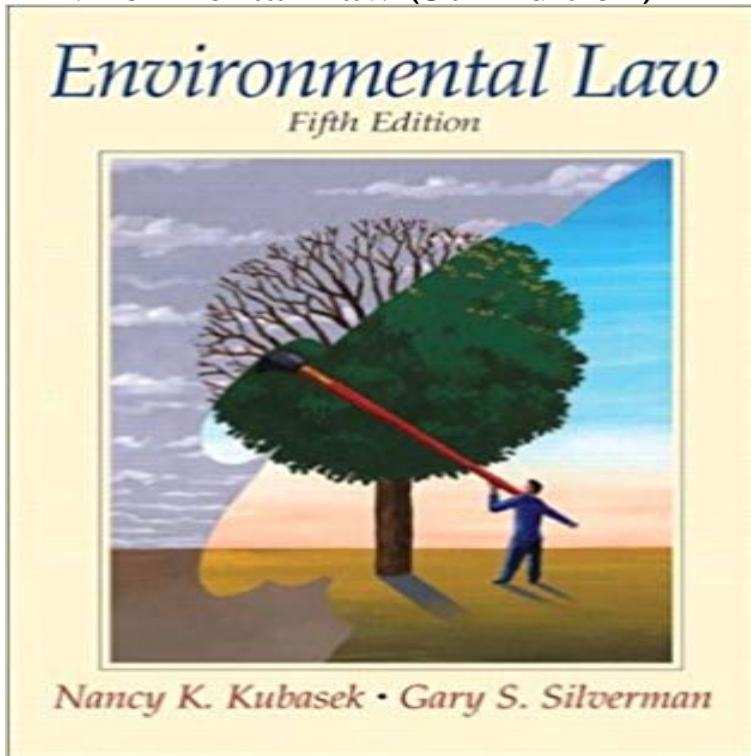


## Environmental Law (5th Edition)
