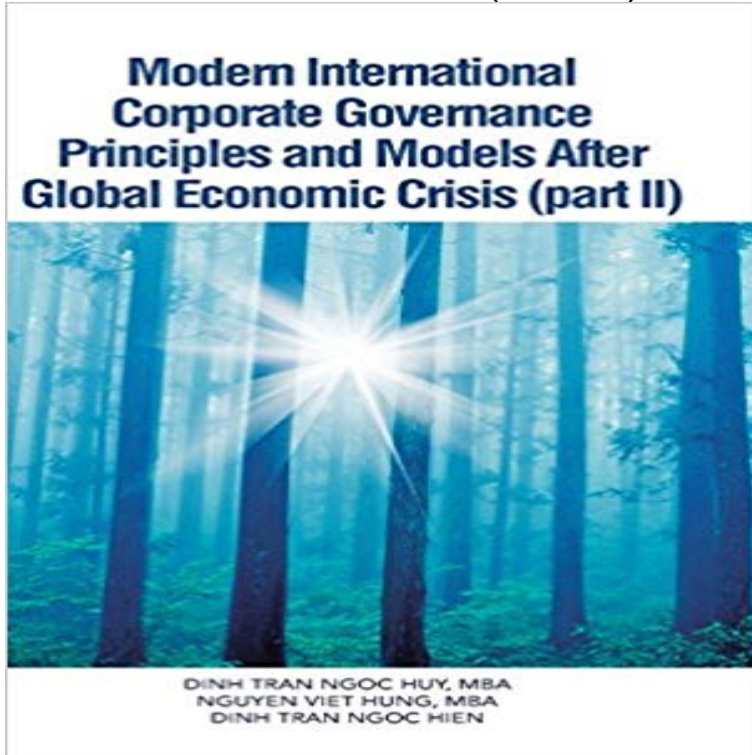


## Modern International Corporate Governance Principles and Models After Global Economic Crisis (Part II)
