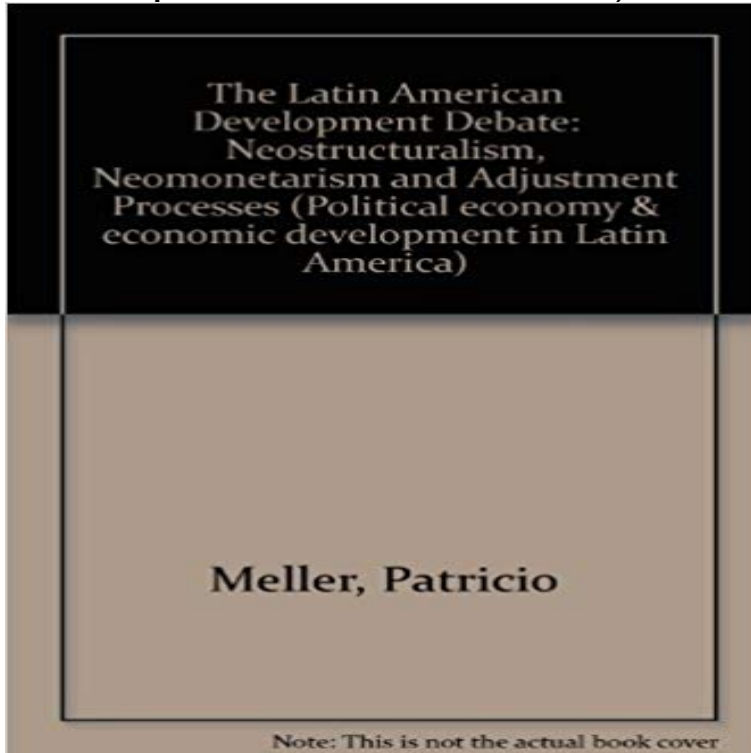


Latin American Development Debate: Neostructuralism, Neomonetarism, and Adjustment Processes (Series in Political Economy and Economic Development in Latin America)
